Answer: Every morning, the crime control group meets at Wilshire Division to map out the occurrences and put a game plan together. for a crime contr **Questions:** Is a police report always filed? If so when?

Answer: Yes. It should be right away. An officer will come to your home to discuss prevention and at time I will give you the report.

Question: If you were a victim of a burglary, do you leave crime scene untouched?

Answer: If it is clothing, you can put them away. Leave doors where the burglar entered untouched.

Question: Are you permitted to protect yourself?

Answer: Yes.

Question: For the people who weren't at the meeting on Wednesday about the burglaries in the neighborhood, is it possible to have that information on the website?

Answer: Claudia stated: "Before we put it on the website we need to review it. Any minutes that are done have to be reviewed before it's on the website to clarify any errors or misunderstandings."
